1. I waive any claim for bodily injury, personal injury or property damage against HEAT Cheer, its directors, employees, agents and insurers (collectively, "HEAT Cheer"), and any owners or lessors of the premises and any equipment used in connection with any programs of HEAT Cheer, arising out of our child's participation in any of the programs of HEAT Cheer whether on or off HEAT Cheer premises, or travel for the purpose of participating in any such programs or events.
2. I understand that this waiver extends to injuries incurred by any member of my family, including my child identified above, any other family member, or myself.
3. This agreement shall remain in effect as long as and whenever our child participates in any activity at or with HEAT Cheer.
4. If this agreement is not effective to waive liability on behalf of our child, any other family member, or ourselves we further agree to indemnify HEAT Cheer for its liability including all costs, fees, and expenses incurred by HEAT Cheer in connection with such liability.

Embers Team Information

Annual Registration Fee (Due with Registration Form. Includes teambuilding, parties, etc.)

\$50 per team member

Team Annual Tuition (Can be divided into 4 equal payments of \$150, May 1st, Aug. 1st, Nov. 1st, and Feb. 1st)

Covers instructions in cheer, dance, stunting & tumbling

Embers Team: \$600 for the entire year - Age 3 – 5

Payments can be made by check, debit card, Master Card, or Visa. A \$25 fee will be added for payments that are more than a week late. Unpaid fees may result in termination from the team.

Practice Day and Time

Embers Team Age 3 – 5 Saturdays 11:00 – 12:00
Age on May 31, 2008 is used for entire season

Tumbling Classes – Optional for Embers team members

All star team members will pay \$75 per session for tumbling classes, which is a discount of more than 50% off of the non-member price. This class is optional but recommended for those who are planning to continue onto another team. It is required for all other teams.

Competition/Exhibition Fees

The Embers team will compete at 3 or 4 competitions during the season.

Fees are charged for all competitions & exhibitions. Fees include coaches' expenses, administrative costs, and entry fees. All competition fees are non-refundable.

Approximately \$40 per competition for local competitions, \$5 per exhibition.

Uniform Expenses

Cheerleaders must purchase their own uniforms. The Embers uniform consists of a long sleeve HEAT uniform top, skirt, and cheer shoes at an approximate cost of \$100. Please see Apparel Order Form for prices.
